

## Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

## Product

**Name of Product:** Invesco Energy Transition Fund (the "Fund"), a sub-fund of Invesco Funds (the "Umbrella Fund"), Class B accumulation - USD, (the "Share Class")

IMSA and the Fund are regulated by the Commission de Surveillance du Secteur Financier (CSSF) in Luxembourg. The CSSF is responsible for supervising IMSA in relation to this Key Information Document ("KID").

## What is this product?

### Type

The Umbrella Fund is established under the laws of Luxembourg and harmonised under the EU Council Directive 2009/65/EC relating to Undertakings for Collective Investment in Transferable Securities (UCITS).

### Term

The Fund does not have a maturity date and may only be terminated in accordance with the terms set out in the Prospectus.

### Objectives

- The objective of the Fund is to contribute towards the global transition towards lower-carbon sources of energy and achieve long-term capital growth.
- The Fund integrates a thematic and an environmental, social and governance (ESG) approach with a particular focus on environmental criteria.
- The Fund invests primarily in shares of companies worldwide which contribute positively to a transition to alternative energies (energy transition) and more efficient and sustainable energy usage across the economy.
- The Fund is managed using "quantitative methods". "Quantitative methods" are defined as mathematical, logical and statistical techniques used for stock selection purposes.
- The Fund selects companies that either are significantly exposed to energy transition and clean energy activities or, in the view of the investment manager, show potential to be leaders in supporting the transition to a low carbon economy.
- In order to assess the companies' exposure, key themes pertaining to energy transition are identified using Natural Language Processing (NLP) algorithms based on unstructured news data, in particular clean energy themes and energy transition and efficiency themes.
- NLP is a field of artificial intelligence which deals with the interaction between computers and humans with the aim to read, decipher and understand the human language in a manner that is valuable for the portfolio construction.
- Screening is employed to exclude companies and/or issuers that do not meet the Fund's criteria on a range of other environmental and social metrics, and the level of involvement in controversial activities.
- Finally, the Fund will be constructed using a proprietary score together with a third party indicator that measures a company's ability to transition to a lower carbon economy.
- The Fund is actively managed and is not constrained by its benchmark, the MSCI World AC Index (Net Total Return), which is used for comparison purposes. However, the majority of the Fund's holdings are likely to be components of the benchmark. As an actively managed fund, this overlap will change and this statement may be updated from time to time.
- The Fund has broad discretion over portfolio construction and therefore

securities, weightings and risk characteristics will differ. As a result, it is expected that over time the risk return characteristics of the Fund may diverge materially to the benchmark.

- The Fund has a sustainable investment as its objective as covered under Article 9 of the Regulation (EU) 2019/2088 on sustainability-related disclosures in the financial services sector.

- You can buy and sell shares in the Fund on any Dealing Day (as defined in the Prospectus).

- Any income from your investment will be reinvested.

### Intended Retail Investor

The Fund is intended for investors aiming for long term capital growth, who may not have specific financial expertise but are able to make an informed investment decision based on this document and the Prospectus, and have a risk appetite consistent with the risk indicator displayed below and understand that there is no capital guarantee or protection (100% of capital is at risk).

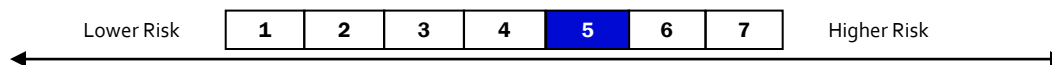

## What are the risks and what could I get in return?

### Risk Indicator



The risk indicator assumes that you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 5 out of 7, which is a medium-high risk class.

This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact the capacity of the PRIIPs manufacturer to pay you.

**Be aware of currency risk. In some circumstances, you may receive payments in a different currency from your local currency, so the final return you will get may depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.**

Other risks such as Stock Connect, ESG and Derivatives risks may impact the Fund. Please refer to the Prospectus for more details.

This product does not include any protection from future market performance so you could lose some or all of your investment.

## Performance Scenarios

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product and a suitable benchmark over the last 10 years. Markets could develop very differently in the future.

The stress scenario shows what you might get back in extreme market circumstances.

The unfavourable scenario occurred for an investment in the benchmark between March 2021 and February 2024.

The moderate scenario occurred for an investment in the benchmark between February 2014 and February 2019.

The favourable scenario occurred for an investment in the benchmark between February 2016 and February 2021.

## What happens if IMSA is unable to pay out?

The assets of the Fund are segregated from those of IMSA. The Depository is responsible for the safekeeping of the assets of the Fund. To that effect, if IMSA defaults, there will be no direct financial impact on the Fund. In addition, the Fund's assets shall be segregated from the Depository's assets, which limits the risk for the Fund suffering some loss in case of default of the Depository. As a shareholder in the Fund, there is no compensation or guarantee scheme in place.

## What are the costs?

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year, you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

\* While the above is not capped, a discretionary cap on multiple components of the total costs is maintained. This discretionary cap may positively impact the performance of the Share Class. The figure is calculated after the application of a partial waiver of the distribution fee. The maximum and actual distribution fee charges are disclosed in the annual accounts.

If you switch funds, you will pay a maximum switching charge of 1% on your new fund, except if you switch into another share class of the Fund after the 4 year period ends.

## How long should I hold it and can I take money out early?

### Recommended holding period: 5 years

We have selected 5 years as the Fund invests for the long term.

You can sell your shares in the Fund on any Dealing Day as defined in the Prospectus.

If you sell some or all of your investment before 5 years the Fund will be less likely to achieve its objectives, however, you will not incur any additional costs by doing so.
